# WHISSENDINE PARISH COUNCIL

Minutes of Parish Council Meeting held on **Monday 3rd February 2020 7.15 pm** in the Village Hall, Whissendine

The Chairman opened the meeting at 19:15 hours.

- 13227 To take any questions or comments from the public: Mr Drabble of Willow Close presented his views of RCC's draft Local Plan particularly the site identified a suitable for development of dwellings: (WHA09/09A/09B) H1.18 off Stapleford Road and east of Willow Close. In his opinion a site of environmental and heritage importance and a LE7796 Natural England registered site and Historic Environment Recorded site MLE 24620 with fossilized medieval ridge and furrow surface. As such he believes the site should be protected from development.
- 13228 Apologies for absence: None received
- 13229 <u>Declaration of any pecuniary interest in any matter on the agenda: None received.</u>
- 13230 <u>Minutes of the meeting held on 6 January 2020 approved</u>; proposed by Mrs Moss and seconded by Mrs Arnold.

# 13231 Reports from Councillors:

- a. Report from Mrs Powell (County Councillor):
  - The draft Local Plan 2018-36 didn't proceed to vote on 27 Jan.; the decision has been adjourned to the 10 Feb 2020 Rutland County Council meeting. There are 2 sites proposed in Whissendine: Melton Road (25 houses) and Stapleford Rd [H1.18] (12 houses).
  - RCC propose that their precept be increased 3.99% (1.99% plus 2% adult social care precept).
  - The grounds maintenance/verges map being is reviewed by RCC and is expected from RCC's contractor by the end of March.
  - RCC's Highways and Transport Working Group is aware that the finger posts in the village are in need of repair.
- Reports of meetings attended by Parish Councillors:
   Mrs Moss reported on the recent meeting of the Village Hall Trustees: They noted they have provided a new boiler system and were dealing with maintenance issues. They acknowledged the grant received from the Parish Council.

#### **13232** Planning matters:

a To consider plans received between 6 January 2020 and 3 February 2020:

**2020/0054/FUL** 20 Sherrard Close: Development relies on removal of garage and will thus lead to loss of on-site parking. The site plan purportedly to scale misrepresents the space between the building and boundary on completion; it is narrower than depicted. Clerk to advise planners.

b Planning updates received:

**2019/1405/CLP** Brunton House, 27A The Nook: single storey rear extension - certificate of lawful proposed use granted.

**2018/1273/FUL** Brunton House, 27A The Nook: Plans inc. gabion baskets around brook and by lake; planning permission granted.

# 13233 The Banks

a Update on play equipment contract:

Installation due to commence week beginning 17 February 2020 and removal and replacement works and assoc. repairs should be completed within 1 week (as per schedule).

- b <u>Decision on supplementary ground surface repairs, following recent flooding:</u> The supplementary ground surface contract, to resurface the area under the 'spinner' and the shelter, will be £697 and this was AGREED.
- c To consider request for installation of steps and handrail on the slope.
  There will be a need to obtain a working design and three estimates of cost.
  Preliminary investigations will be undertaken and this matter will be included in the March agenda.
- d Other issues:

The contractor has confirmed he proposes no increase to charges for grass cutting, etc. so rates will remain as per 2019 rates.

# 13234 Highways and Village Maintenance matters:

It was noted that 2 rainwater gulleys in Station Road carriageway are blocked, the eastern one seems to be collapsed (reported 6/2/2020).

Path on west of bridge towards treatment works, hole in path and loose kerb stones (reported 5/2/2020).

# 13235 <u>Financial Business</u>

a To receive the details of expenditure to date: The accounts were reconciled with bank statements on 4 January 2020 and there was £17857.08 available. £1705.52 expenditure was allocated in January and two payments were received leaving £16242.56 available for allocation in the rest of the financial year.

It was noted that two donations to the Parish Magazine have so far been received.

- b To confirm signatories for change of mandate: It was AGREED that for the bank accounts held by Whissendine Parish Council with the HSBC Bank plc the signatories shall remain: Dr Susan Lammin (as Clerk and Responsible Financial Officer); with elected-Members Mr Will Farr, Mrs Pat Lake and Mrs Linda Arnold continuing as authorized signatories.
