Mr Vallett had concerns about the planning appeal for Little Spice Box.

Mr Harman wanted the advisory Flood Signs to be provided by RCC, soon.

Declaration of any pecuniary interest in any matter on the agenda: Mrs Moss lives adjacent to Little Spice Box (Item 13631b below).

To approve minutes of the meetings held on 7 November 2022: Proposed, Mr Thomas and seconded Mrs Wilkins, the minutes were approved and duly signed by the Chairman.

#### **13630** Reports from Councillors:

a. Reports of meetings attended by Parish Councillors

Mrs Moss reported on Village Hall AGM: Heating costs an issue. Income down with loss of pre-school.

Mrs Moss reported on Air Space meeting, another meeting scheduled for Spring 2023; there will be another update. The easterly departure route, nearest Whissendine, removed from plans. Nothing low over the village.

b. Report from Mrs Rosemary Powell, Rutland County Councillor. Mrs Powell sent apologies due to RCC meeting clash. She supplied a written report: She has chased provision of the flood signage (ITCP-2022-12) and has offered to notify any progress. She offered congratulations to the Neighbourhood Plan Steering Group on reaching the public consultation stage so speedily.

RCC's Multum awards ceremony was Saturday 3 December and Mrs Sarah Bysouth won the award for event organizer and Mrs Pat Lake was nominated for the Public Servant Award for her 32-year service on Whissendine Parish Council.

Today, notification was received that the planning decision for the large development off Stapleford Rd has been issued by RCC. There were delays in the developer finalising the s106 agreement and paying the fees. It is expected the appeal will not now proceed [Note: notification of withdrawal received by WPC 12.37hrs 5/12/22].

## 13631 Planning matters

**2022/1318/FUL** 23 Hall Close – sing. storey rear extension with pitched roof: No comments offered

**2022/0529/MAF** Land south of Melton Rd – residential dev. (Revisions): It was agreed that the comments already offered should be resubmitted together with a copy of the surface water distribution diagram for the local area. Since the last comments were offered expert advice has been sought, and provided, about local fluvial catchment.

- b) Planning appeals: to consider if further comments should be offered and whether to appoint a councillor to represent the Parish Council's views at a hearing:
  - i. Muller Property Group **2021/0029/APPEAL** (APP/A2470/W/21?3285028) re Land south of Stapleford Rd for dev. of up to 66 dwellings (outline) and access. This appeal has been withdrawn see item 13630b above.
  - ii. Mr Odedra **2022/0022/APPEAL** (APP/A2470/W/22/3301045) re 39B Main St -s73 application to vary conditions to allow opening to 10.30pm every day inc. Bank Holidays. It was AGREED previous comments should be reiterated, removing reference to Covid 19. There in an error in the appellants statement in that he says that the adjacent Village Shop is open until 10pm every night; that shop shuts at 7pm every week-day evenings, 5pm on a Saturday and Noon on Sunday. The footprint of the current café has been described as part of the main building but was never part of the previous Bistro, the extension was a delicatessen and Post Office adjacent to the Bistro operated by the same proprietors. The parish council note that Public House in the village is not open 7 days a week to 10.30pm.
